BRIMMER

Please do what they say or they'll kill me!

TINS

(calmly)

That's true. You should listen to her. He will kill her. He wants to.

REESE

Chip! Drop the gun. Let her go.

TINS

That is not going to happen.

(off their looks)

Because today is my day. Today I get anything I want. This morning I was on that prison work detail and I saw the city shake for me, then she laid right down and spread her legs... for me. What I had planned on taking months? It all happens today. Because today is my day.

(beat)

And if I want her to die on my day? Chip there will kill her for me.

CREWS

I made a promise to Mark Rawls that you'd go back to prison, Arthur.

TINS

Yeah, I don't think so. I don't really feel that the institution has any more to teach me.

Crews uncuffs Tins who walks toward the armored car, then stops and turns. Crews and Reese point their guns at him.
